Tuition

Every student must pay a **\$50 Registration Fee** prior to the start of the dance season. Class Tuition is assigned by the amount of time the student is registered for class per week.

The Company

Company, POINTE! II, Apprentice: \$315

Includes 6 hours of Company pre-assigned classes plus 2 additional hours of TC Level classes. (8 hours total)

Petite Company: \$190

Includes 2 hours of pre-designated company classes and 2 additional hours of TC level classes. (4 hours total)

Company members can take classes beyond their included hours at a half off rate.

Tuition is due by the 1st of each month or before you start class. A non-negotiable \$35 late fee will be added to your child's account after the 5th of each month. If payment is not received during the grace period and there is no communication, your child will not be able to attend classes at The Pointe! until your balance is paid in full. Payments made after the last day of the month are subject to an additional \$20 fee per month late and the performer must sit out of class until the payment is made in full.

Tuition is still due during holidays, studio closings, and absences.

You may chose to pay in the following ways: utilize PayPal, have your performer bring in the payment in an envelope and give to office staff, mail your payment, use a credit card over the phone, or place a check or money order in the mailbox outside of the studio.

If you chose to use **PayPal**: go to **paypal.me/thepointe**, type in the amount of your payments put your dancer's name(s) in the notes/special instructions, as well as, what you are paying for **(ex. Tasha Avery, September Tuition, and Production Fee)**.

Attendance: Regular class attendance is very important to your dancer's progress. Excessive tardiness will not be tolerated. However, if your child must miss a class or is going to be late, please notify the office. If your child should miss more than 3 consecutive classes and the office is not notified, the student will automatically be withdrawn from the conservatory. If your student is administratively withdrawn, YOU ARE STILL RESPONSIBLE FOR ALL FEES AND TUITION UNTIL WE ARE OTHERWISE NOTIFIED OF YOUR OFFICIAL WITHDRAWAL IN WRITING.
